

Footnotes and Bibliographies

In academic writing, the Bibliography is on a separate page at the end of the paper and bibliographical entries are arranged in alphabetical order using "hanging indent" format.

1. A Book by a Single Author

13. Electronic Book

Cite the print edition of a book when possible. If this is not possible, indicate the format consulted (e.g. Kindle edition). Also, since e-reader formats do not have stable page numbers, in lieu of a page number, include a chapter or section number in the citation:

14. Electronic Book part 2

When citing an online version of a book, include the DOI. In the absence of a DOI, include the URL in the citation.

For Articles written by more than one author, follow the examples above in, "A Book by Two or Three Authors, and A Book by More Than Three Authors." It is unnecessary to include the issue number unless the journal volume is not paginated consecutively.

16. An Unpublished Dissertation or a Thesis

17. An Article in an Encyclopedia or a Dictionary

Individual articles in an encyclopedia or a dictionary should be included in the bibliography. The article form applies. The volume and page number may be placed immediately after the abbreviation without an intervening comma. This imitates the rule for journal volumes. Multivolume lexicons, collections of primary sources, and dictionaries are candidates for this special treatment. For examples see the *"An Article in a Lexicon or a Theological Dictionary" below.*

For the discussion of a word or a family of words, give the entire title and page range of the article:

Bibliography form (cite the theological dictionary as a whole)

Beyer, Hermann W. *Theological Dictionary of the New Testament*. Translated by Geoffrey W. Bromiley. 10 vols. Grand Rapids: Eerdmans, 1964–1976

19. Websites (N.B. Website articles without authors, who can be verified as experts in their field, should be avoided in academic writing.)

A web page citation must include the time stamp that the website was last modified or, if none can be found, the access date. Footnotes should include the specific content used; this is only necessary in your bibliography if it is critical to your argument.
